Philanthropy, Voluntarism and Grant Making Programs: The grant cycle for the fiscal year ended June 30, 2017 resulted in pooled distributions to Idaho non-profit organizations of \$233,000. Also, for the fiscal year ended June 30, 2017, members directed distributions of \$188,500 to individually selected non-profit organizations and \$13,855 from the endowment. Idaho Women's Charitable Foundation (IWCF) educates women about community needs and inspires members to positively impact the community through educated philanthropy. Over 376 IWCF members participate in a collaborative effort to identify and distribute grants to those Idaho non-profit organizations providing services to the community in the areas of cultural arts, education, financial stability, environment, and health. By collaborating on grant funding decisions and attending IWCF sponsored educational events, members develop the skills and knowledge necessary to make informed grant choices. (There were 21 Pooled Grant recipients.)

Schedule I, Part I, Line 2 - Idaho Women's Charitable Foundation (IWCF) accepts grant proposals annually from qualifying non-profit organizations, carefully researches their viability and evaluates their needs. The organization includes their IRS determination letter that they are a qualifying 501(1)(c)(3) organization as part of the application package. IWCF members then select the projects by voting in the areas of cultural arts, education, environment, financial stability and health. In addition, one Above and Beyond Collaborative (ABC) grant was selected addressing an immediate need for the very lowest-income citizens. In 2017, 48 members participated on the Grants Committee to narrow 90 letters of inquiry to 10 ballot choices in the 5 interest areas. In the fiscal year ending June 30, 2017, the IWCF distributed \$233,000 in pooled grants and \$188,500 in individually designated grants. There were 189 qualifying organizations receiving the individually designated grants in amounts of \$250 and \$500.
