As Director of Economic Opportunity (EO) by Jannus, Kelli's focus is on meeting its mission of empowering the underserved to realize economic mobility, a vital outcome for achieving inclusion, self-sufficiency, and a healthy local economy. She is an active volunteer who gives her time in a variety of roles with Idaho Women's Charitable Foundation, the Homeless Coalition of Southwest Idaho, Women Innovators (W.IN), and St. Luke's Health System.



Diane Bevan is the CEO of the Idaho Hispanic Foundation and the Executive Director of the Idaho Women's Business Center and Idaho Connect Community Navigator Programs. She has built her career on being a connector and building ecosystems. From an early entrepreneur at age 16 to owning an event venue and 2 retail prom/bridal stores, she knows first-hand the barriers women face in business. Her constant drive to empower women and serve the underserved shows in her community and servant leadership. She is a 2019 and 2020 IBR Woman of the Year honoree, 2021 CEO of Influence, and most recently a 2022 top 50 Most Influential Business Leaders in Idaho. 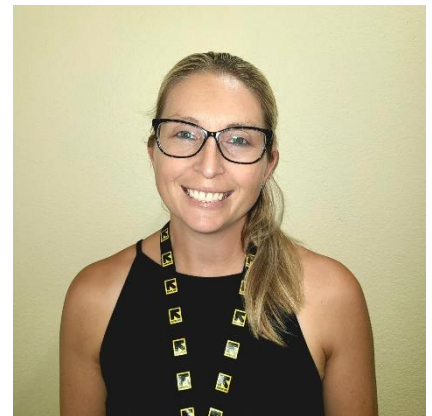
